

## *History of Accomplishments*



The Plano ISD Education Foundation has dramatically increased private support for critical needs of Plano ISD during the last six years, with \$45,000 gifted in 2001, \$600,000 in 2006 and a \$1,000,000 fundraising goal surpassed in 2007. All donations to the Plano ISD Education Foundation stay in Plano ISD and address priority programs identified by the district for which tax dollars are not available.

Since 2001, more than \$2 million has been gifted to Plano ISD for programs and services.

- \$200,000 has been granted to Plano ISD educators to fund innovative instructional projects in classrooms across the district,
- \$100,000 has provided scholarships for disadvantaged students to attend Plano ISD fifth grade environmental camp,
- \$100,000 has supported programs that recruit, retain and recognize outstanding teachers,
- \$80,000 has assisted Plano ISD employees experiencing short term personal emergencies, and
- Hundreds of thousands of dollars have funded specific programs identified by the district that improve the academic performance of all students.
- The Plano ISD Education Foundation was recognized by the Volunteer Center of Collin County as the Volunteer Group of the Year in the Education Category in 2005.
- In 2007, more than 2800 Plano ISD employees donated a total of \$98,000 to the Plano ISD Education Foundation through the district's annual employee fundraising drive, validating the importance of Foundation-sponsored programs to Plano ISD educators.
