Daffron Elementary School Title I Parent and Family Engagement Policy 2024-2025

Daffron Mission Statement:

Daffron Elementary agrees to implement the following statutory requirements:

- 1. Daffron Elementary will take the following actions to involve parents in the joint development of its school parental involvement plan under section 1118 of the ESEA by volunteering in their children's schools through involvement in PTA programs, field trips, classroom support, etc.
- 2. Daffron Elementary will take the following actions to involve parents in the process of school review and improvement under section 1116 of the ESEA by participating in site-based leadership and decision-making through the PTA and Daffron's Site Based Improvement Committee.

Daffron Elementary will provide parents of participating children information in a timely manner about Title I, Part A programs that includes a description and explanation of the school's curriculum, the forms of academic assessment used to measure children's progress, and the proficiency levels students are expected to meet by respecting parents as partners in the education of their children. Parents are included in reviewing

- 5. Daffron Elementary will, at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible.
- 6. Daffron Elementary will provide a welcoming and supportive environment for parents. Our goal is to increase parent communication and build relationships and partnerships with parents and community members. We have a school counselor who supports both student and family needs. Our Office staff is expected to be welcoming and sensitive to the needs of all parents. Beginning and ending year surveys are taken by Daffron parents to identify needs and monitor progress of program goals.
- 7. Daffron Elementary will provide each parent an individual student report about the performance of their child on the State assessment in at least math, language arts and reading.
- 8. Daffron Elementary will take the following actions to provide each parent timely notice when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not highly qualified within the meaning of the term in section 200.56 of the Title I Final Regulations (67 Fed. Reg. 71710, December 2, 2002) by sending Notice of Qualification letters to families.
- 9. Daffron Elementary will provide assistance to parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described in this paragraph --
 - the state's academic content standards,
 - the state's student academic achievement standards,
 - the state and local academic assessments including alternate assessments,
 - the requirements of Part A,
 - how to monitor their child's progress, and
 - how to work with educators:

Federal, state, and local funds are used to support the Daffron's efforts to meet the needs of parents through various campus programs. Examples of how Daffron is attempting to support the needs of ALL parents include family engagement activities, academic instructional information nights, webinars, newsletters, parent-teacher conferences, as well as other district/campus level parenting programs and adult ESL classes, etc.

- 10. Daffron Elementary will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parental involvement, by providing opportunities to reinforce learning at home, discipline, and understanding cultural differences.

Attending school events; webinars; parenting classes; family engagement activities and curriculum nights help to empower parents, and improve student academic achievement. Information about District ESL classes for adults are also made available to families.

Daffron Elementary will, to the extent feasible and appropriate, coordinate and integrate parental involvement programs and activities with Head Start, Reading First, Early Reading First, Even Start, Home Instruction Programs for Preschool Youngsters, the Parents as Teachers Program, public preschool, and other programs. The school will also conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children, by valuing the need for partnerships between the School District and the community. Daffron actively seeks ways to support academic and parent programs at our campus.

Daffron Elementary will take the following actions to ensure that information related to the school and parent-programs, meetings, and other activities is sent to parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand by establishing and promoting two-way communication as a source of trust and understanding between the school and parents. This is accomplished through parent-teacher communications such as email, campus/grade level/classroom newsletters and/or Seesaw, campus web pages, phone calls/School Messenger, etc. Information and school reports are provided in an understandable layout, and when practical, in a language parents understand.
