



# Collin College-Plano ISD Fall 2021 Dual Credit

## All Dual/Concurrent Credit Enrollment Procedures Must Be Completed by May 3, 2021

### Complete these steps:

#### 1. Apply (for *students new to dual credit*)

- Complete the Collin College application online at [https://www.collin.edu/gettingstarted/admissions/online\\_app.html](https://www.collin.edu/gettingstarted/admissions/online_app.html)
- Application **MUST** be completed before any paperwork will be processed.
- Student will receive an email message from Collin College after the application has been processed.
- CWID# will be noted in that email message, then give your CWID # to your PWSH counselor

#### 2. All new and returning dual credit students must complete and email the following forms to their Plano West Counselor by **April 20, 2021**

This form is required on file at Collin College for **each semester**. It must be signed by a PWSH counselor, the student, and a parent/guardian if the student is under the age of 18.

#### 3. Remove All Holds

- A hold for the Dual/Concurrent Credit High School Registration Permission Form will appear on the student's Cougar Web account until Collin College processes the forms
- If student is not eligible for a TSI exemption or waiver, please take the **Texas Success Initiative (TSI) Assessment** at a Collin College campus. **Steps include:**
  - Review email from [assessmentcollincollege@collin.edu](mailto:assessmentcollincollege@collin.edu) or go to [collin.edu/studentresources/testing/availabletesting/tsi.html](http://collin.edu/studentresources/testing/availabletesting/tsi.html)
  - Complete the Pre-Assessment Activity (PAA) sent to you electronically and print your certificate of completion.
  - Pay the \$29 testing fee online at <https://www.collin.edu/studentresources/testing/availabletesting/tsi.html> or at Cashier's Office. A \$29 fee will be charged for **retakes**.
  - Take the PAA certificate of completion, a photo ID and payment receipt to the Testing Center during walk-in hours.
  - See an Academic Advisor after testing to discuss your results.
- Complete Mandatory Campus Safety Training located on the STUDENT tab in CougarWeb

#### 4. Complete Online Registration and Payment

**Students must register and pay online after holds are cleared by 8PM on May 3, 2021**

Students **will register & pay online via CougarWeb**. Use the CRN numbers given to you by your PWSH counselor. Do not share CRN numbers with other students.

### Steps for Online Registration & Payment for Dual Credit Courses at PWSH – deadline May 3, 2021

1. Go to [www.collin.edu](http://www.collin.edu) and log in to CougarWeb
2. Go to **Registration and Planning** under Registration Tools
3. Click on **Add, Drop or Withdraw**
4. Select the registration term (**Credit Fall 2021**), then click **continue important**: Registration term must begin with credit and not Cont Ed (Continuing Education)
5. Click on the **Enter CRNs** tab **above** the search boxes and input the **5 digit CRN** for each of your courses
6. Click **Add to Summary**
7. Click **Submit** (in the bottom right corner of the screen)

#### Complete Registration & Tuition Payment

- Students may pay in person at the Cashier's Office or online via CougarWeb.
- Payment is required each semester.
- Plano ISD dual credit online registration and payment deadlines differ from Collin College's deadlines.
- **Plano ISD registration & payment deadline is 8p.m. on May 3, 2021**
- Plano ISD students on free or reduced lunch do not have to submit tuition payment but **must** complete online registration.
