



Davis School Parent Engagement Policy

PART I. GENERAL EXPECTATIONS

Davis Elementary agrees to implement the following statutory requirements:

9. Davis Elementary will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parental involvement, by:

10. Davis Elementary will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff in how to reach out to, communicate with, and work with parents as equal partners in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by: (due to Covid-19 ongoing pandemic these activities have been minimal for safety reasons.)

11.
