



Parent Engagement Policy 2019-2020

PART I. GENERAL EXPECTATIONS

Davis agrees to implement the following statutory requirements:

5. Davis will at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible by:
 - *Staff will respond to parents within 1-2 work days of receiving a message.*

6. Davis will provide each parent an individual student report about the performance of their child on the State assessment in at least math, language arts and reading by:
 - *Sending home with student/mail reports to students' home address*
 - *Parent Portal*

7. Davis will take the following actions to provide each parent timely notice when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not highly qualified within the meaning of the term in section 200.56 of the Title I Final Regulations (67 Fed. Reg. 71710, December 2, 2002) by:
 - *A letter will go home to parents detailing the information.*

8. Davis will provide assistance to parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described:
 - the state's academic content standards,
 - the state's student academic achievement standards,
 - the state and local academic assessments including alternate assessments,
 - the requirements of Part A,
 - how to monitor their child's progress, and
 - how to work with educators:
 - *Parent information meeting during the second week of school*
 - *Conferences throughout the year*
 - *Parent Academy meetings throughout the year at various times*

9. Davis will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parental involvement, by:

 - *Multiple academic nights throughout the year*
 - *Parenting workshops*

10. Davis will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff in how to reach out to, communicate with, and work with parents as equal partners in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:

11. Davis will, to the extent feasible and appropriate, coordinate and integrate parental involvement programs and activities with Head Start, Reading First, Early Reading First, Even Start, Home Instruction Programs for Preschool Youngsters, the Parents as Teachers Program, public preschool, and other programs.
