

Exhibit B—Student Agreement for Acceptable Use of the District’s Technology Resources

Plano ISD students are given access to a variety of District-provided technology resources. With this opportunity comes responsibility. It is important to understand the kinds of things you may do, and must not do, with the technology resources provided.

Students will use the District's technology resources primarily for learning.

Use Technology Resources Responsibly:

- Be Careful: Don't be afraid to use the District’s technology resources, but keep them and yourself out of harm's way.
- Be Productive: Use digital tools to help you work, learn and create in powerful ways.
- Be Respectful: Only choose words and images that are appropriate and considerate of others.
- Be Smart: Keep your personal information private. Be a critical thinker. Ask questions and be skeptically curious about the content you see and read online.

The Rules for Acceptable Use Apply to All Students:

- You are responsible for your digital accounts and everything done with those accounts.
- Logging on to a computer or platform using someone else’s account is not allowed.
- Creating, sharing, saving or intentionally accessing inappropriate content is prohibited.
- Damaging equipment, materials, or data on purpose is not allowed.
- Attempting to disable or bypass the District’s filtering and/or security services is prohibited.
- Sharing copyrighted material without permission is not allowed.
- Distributing personal information about yourself or others is not allowed.
- Never make appointments to meet people in real life or online without parent/guardian approval.
- Students should always report inappropriate online interactions to a parent, teacher, counselor or administrator.
- Students must not engage in academic dishonesty, which includes cheating or copying the work of another student, plagiarism, the impermissible use of artificial intelligence, and unauthorized communication during an examination.

Guidelines for Using Generative Artificial Intelligence (AI) Tools for Schoolwork:

- Students may only use Generative AI tools for schoolwork with teacher and parent/guardian permission.
- Students should never share personally identifiable information related to themselves, other students or staff with an AI tool.
- Students must be open and honest about their use of Generative AI tools.
- Students must always check the output of Generative AI tools for accuracy and appropriateness; Generative AI tools can make mistakes.
- Students are completely responsible for the work they claim as their own.

Reporting Violations:

- You must report any requests for personally identifiable information or contact from unknown individuals to a teacher, guidance counselor or campus administrator.
- You must report any content or communication that is abusive, obscene, pornographic, sexually oriented, threatening, harassing, damaging to another's reputation, or illegal to a teacher, guidance counselor or campus administrator.

Inappropriate use of technology resources may result in losing the privilege of access. Depending on the seriousness of violations, there may be other disciplinary or legal consequences according to the Student Code of Conduct and applicable laws.
