Major Responsibilities and Duties:

Instructional Management

- 1. Encourage and support development of innovative instructional programs, helping teachers pilot such efforts when appropriate. Participate in program evaluation measures and make suggestions for improvement where needed.
- 2. Reinforce expectations for staff performance with regard to instructional strategies and classroom management.
- 3. Foster collegiality and team building among staff members. Encourage their active involvement in decision-making process.
- 4. Assist principal in designing and delivering professional development for staff.

School/Organizational Improvement

- 5. Take a leadership role in planning activities and implementing programs to ensure attainment of the school's mission.
- 6. Participate in development of campus improvement plans with staff, parents, and community members.
- 7. Help principal develop, maintain, and use information systems to maintain records and track progress on campus performance objectives and academic excellence indicators.

Student Management

- 8. May act as campus behavioral coordinator in accordance with state laws and regulations.
- 9. Work with faculty and students to develop a student discipline management system that results in positive student behavior and enhances the school climate.
- 10. Ensure that school rules are uniformly applied and that student discipline is appropriate and equitable in accordance with Student Code of Conduct and student handbook.
- 11. Conduct conferences about student and school issues with parents, students, and teachers.
- 12. Assist in supervision of students to ensure the safety of all.

13. Oversee campus operations in principal's absence.

- 14. Take a leadership role in planning and scheduling of daily school activities including the development of class schedules, teacher assignments, and extracurricular activity schedules.
- 15. Oversee reporting and monitoring of student attendance and work with staff to identify and address issues.
- 16. Work with department heads and faculty to compile annual budget requests based on documented program needs.
- 17. Requisition supplies, textbooks, and equipment and monitor and maintain inventory in accordance with district procedures.
- 18. Coordinate operational support services such as transportation, custodial, and cafeteria to best meet campus needs.
- 19. Comply with district policies, state and federal laws, and regulations affecting schools.

Personnel Management

- 20. Observe employee performance, record observations, and conduct evaluation conferences. Serve as second appraiser as needed for designated teacher appraisal system.
- 21. Participate in the interviewing, selection, orientation, and recommendations relative to personnel placement, transfer, retention, and dismissal.

- 22. Articulate the school's mission to community and solicit its support in realizing the mission.
- 23. Demonstrate awareness of school-community needs and initiate activities to meet those needs using appropriate and effective techniques to encourage community and parent involvement.
- 24. Participate in community activities (to the extent possible and appropriate) that foster rapport and mutual respect between the district and the larger community.
- 25. Assist with coordination and supervision of special programs/activities.

- 26. Follow district safety protocols and emergency procedures. Cooperate in the conducting of safety inspections and safety drill practice activities.
- 27. Pursue leadership opportunities that will enhance decision making, strengthen communication and interpersonal skills.

- 29. Demonstrate behavior that is professional, ethical, and responsible and serve as a role model for all district staff.

- 32. Perform other functions that may be assigned by the Administration and/or supervisor.
