Performance Objective 1: 9-12 READING LANGUAGE ARTS

Approximately 94% and 91% of students attending Plano West Senior High have met standard for English I and English II STAAR respectively. At Plano West Senior High, the only students taking English STAAR assessments are students that have previously failed to meet standard multiple times and those that have moved from out of the country. As a result the testing data only represents a very small subset of students that have very high needs. Without this context the following performance objective may be misleading. The percentage of students that score Meets grade level or above on STAAR English I and II will increase from 13% in 2022 to 14% by June 2024. The Economically Disadvantaged student group performance will increase from 10% in 2022 to 14% by

2024.
