Goal 1: Use formative assessment data to identify students demonstrating early mastery of learning standards in reading and mathematics and increase opportunities for enrichment instruction.

Performance Target: The percent of quintile 1 students' projected growth met on Reading and Math MAP will increase as will students scoring an achievement level of masters on STAAR

Expected Result: Increased access to appropriately challenging curricular and instructional opportunities

Priority 2: Pillar 1: Teaching and Learning

1.2 Develop and deliver systems for learning that articulate expectations and provide support for all staff, campus administrators and district office leaders to ensure engaging, high levels of learning for all students.

Goal 1: Use the Revised PISD Collaborative Team Framework with a focus upon the Prevention Cycle and Question 4, "How will we increase our instructional Practice and competence?" to grow informed decision making and intentionality in science planning and instruction.

Performance Target: The percent of students scoring an achievement level of meets and masters on STAAR will increase.

Expected Result: Teaching staff will improve implementation of collaborative team processes and students will acquire a deeper understanding of science concepts and the ability to apply conceptual knowledge in varied situations and representations.
