Performance Target: By the end of the 2024-2025 school year, the percentage of students in grades 2-5, who perform at meets or above, will increase from 25% to 50% on math MAP.

Performance Target: To increase the percentage of students in grades 2-5, who perform at meets or above on reading MAP, from 38% to 50%.
